3. Child & Play Therapy Specialist

- Provide developmentally appropriate therapeutic interventions, primarily Play Therapy, for children (ages 3-12).
- Engage parents/caregivers in collateral sessions to support the child's treatment goals.

- Strong verbal and written communication skills for clinical documentation.
- Ability to work independently and manage a clinical caseload.
